### **INSURANCE MATTERS**

**Private Investigators** In a letter dated Aug 24 1994 Mr. David Christopherson, MPP Hamilton Centre, Solicitor General & Minister of Correctional Services wrote as follows:

"Private Investigators in Ontario are licensed under the <u>Private Investigators and Security Guards Act, R.S.O.</u> administered by the Private Investigators and Security Guards Section of Records and Registration Branch, Ontario Provincial Police (OPP). The RCMP are not involved in this process.

Applicants for licences are required to meet the following standards established by the Registrar:

- 1. 3-5 years investigative experience;
- 2. proven knowledge of related legislation and of the field;
- 3. police investigation conducted into applicants' suitability:
- 4. applicant required to post a \$5,000.00 bond and insurance totalling \$1,000.

Private Investigators' licences are renewed on an annual basis and no legislation empowers Private Investigators with greater rights or powers than those of private citizens.

Complaints against Private Investigators may be reported to the Investigative Unit, Private Investigators and Security Guards Section, Records and Registration Branch, Ontario Provincial Police, 125 Lakeshore Boulevard East, Toronto, ON M5E 1P6, Telephone No. (416) 326-0033, Fax No. (416) 326-0034.

**INSURERS' MISCONDUCT:**"If the Superintendent considers that the conduct of a financial institution is misleading, deceptive or unconscionable, he may institute proceedings with a view to protecting the rights of an insured. However, in this situation it is difficult to conclude that the actions of the insurance companies are misleading, deceptive or unconscionable, given the divergence of medical opinions on

Myalgic Encephalomyelitis/Chronic Fatigue Syndrome and/or Fibromyalgia and given that the doctors who express such opinions have their own professional standards of independence to which they must adhere." # Insurers' 'independent medical report'?

**ONTARIO -** Blair Tully states in his letter of Oct 12/94 "To the extent there may be doctors who are not prepared to accept ME as a genuine medical condition, I would suggest this is a matter more appropriately considered by the Ontario College of Physicians and Surgeons. Similarly, if there is evidence to suggest that a physician is deliberately alteg his or her findings and opinions, that might be a matter that warrants reporting to the Ontario College of Physicians and Surgeons." **NEW BRUNSWICK -** "There is no definition on this matter in the New Brunswick Insurance Act, nor haveprovided any guidelines to the industry. In my experience, these situations are usually resolved through a mutual understanding of all parties as to who is acceptable in providing an independent medical report. It is usually the interpretation of the medical reports that creates disharmony, e matter may need to be resolved in a court of law.....New Brunswick does not maintain records on specific losses or claims...."Signed R.W. [Editors note: As disability insurance is a provincial issue, the provincial equivalent of the OntarioCollege of Physicians and Surgeons is the appropriate body to deal with these matters in other provinces.]

**TIP: 1)**Whenever you need to make an important phone call or write an important letter, be sure to call or write the same contact person who would be familiar with your file.

- 2) When you get a call from an important contact but it is made by phone, follow it up in writing, outlining the particulars of that call. This information can become important if there is a disagreement as to what was decided on the phone and what actually happened. This way, if the contact does not agree with what you wrote or what they thought transpired, they will be forced to write you a rebuttal.
- 3) Whenever possible, keep notes of important events in your life, on either a daily or weekly basis so that you can keep track of developments.

#### Q: Who is responsible for handing out grants?

**A**: Dr.Campione-Piccardo replies in his letter of June 9, 1994 as follows: "The main agencies granting support to researchers who may wish to contribute to a better understanding of ME/FM are the Medical Research Council and the National Health Research Development Program (NHRDP). These agencies assign grants through a peer-reviewed competitive process on the basis of perceived merit. Every Canadian with the required qualifications can apply for different types of grants to carry out research in ME/FM in different universities or other institutions." ### **HEALTH QUESTIONS**

Introduction: We are very pleased to announce that Dr. Jain has agreed to contribute his valuable expertise to our Newsletter. As you probably know, in addition to his general practice, Dr. Jain has seen thousands of M.E./CFS patients. He will discuss matters which appear to be of particular concern to these patients.

## Dear Dr. Jain: Q: What is your opinion on Flu Shots?

**A:** The Flu shot generally gives immunization against the most prevalent virus strains of that year. However, it does not prevent common colds or bacterial infections.

The flu shot is presently recommended for any person over the age of 65 and those who have a serious illness, such as cardiovascular or lung disease. These individuals are most vulnerable to death by the influenza virus.

The flu shot is generally not required for ME/CFS patients. At our clinic, we generally recommend it to patients who are having repeated significant respiratory infections which may resemble influenza. These include symptoms of fever, frontal headaches, muscle pain, and a non-productive cough. However, in the above- mentioned vulnerable group, these individuals can become severely sick with even pneumonia with possible death.

These symptoms, however, do not include the non-specific flu-like symptoms often seen in ME/CFS.

Also, as an already compromized immune system is further taxed with the flu shot, we do not recommend it for severely ill ME/CFS patients or patients who have not plateaued in their health. **Anil Jain, M.D.**, 118 - 1025 Grenon Ave., Ottawa, ON K2B 8S5 - Tel. (613) 596-3211.

### <u>Australia - A Urinary Biomarker?</u>

Mr. Jim Oakley of the M.E./Chronic Fatigue Syndrome Society of Victoria Incorporatedreceived the following reply from Professor Tim Roberts of the University of Newcastle who provided him with the following information:

The abstract presented at the Dublin conference is the only published work at this stage.

His team [Prof. Roberts] has seven manuscripts to send out for publication when all the legal details are worked out.

The test is not available at the moment because it requires a long and involved analytical procedure using gas chromatography combined with mass spectrometry.

A clinical trial which will assess the usefulness of the test will be conducted at the Royal North Shore Hospital in Sydney [Australia].
